Bidders may obtain one (1) set of bidding documents, beginning Monday February 13, 2006 by contacting the Construction Manager, **McCarthy & Smith, Inc.**, at (248) 427-8400. Additional plans may be ordered and purchased directly from Dunn Blue Reprographics Technology, (248) 353-2950. Bids are to be submitted in a sealed envelope supplied by the Construction Manager. The bid division(s) being bid is/are to be identified on the outside of the envelope.

There will be NO Pre-Bid Meeting. Questions regarding the project shall be directed to McCarthy & Smith, attention Steve Banchemo.

A sworn and notarized statement disclosing any familial relationship existing between the bidder and any member of the school board, school superintendents, or chief executive must accompany each bid. The Allen Park Public Schools Board of Education will not accept a bid that does not include this statement. This statement is on the proposal execution form.

Each bid shall be accompanied by a Bid Bond in the amount of five (5) percent of the amount of the bid, payable to Allen Park Public Schools, as a guarantee that if the proposal is accepted, the bidder will execute the contract and file the required bonds within ten (10) days after notice of award of contract.

If awarded a contract, the successful bidder may be required to furnish a Performance Bond and Labor and Material Payment Bond in the amount of 100% of the contract price. Allen Park Public Schools reserves the right to reject any or all bids received, to waive any informalities and irregularities in the bidding, and to accept a bid other than the lowest bid.

This project is to be bid at the prevailing wage rate.
