Ann Arbor Public Schools is committed to having maximum Historically Underutilized Business (HUB) participation on the project. Barton Malow Company will have the expectation that bidders will conduct themselves in good faith in the utilization of HUB's on the project
4. Unless otherwise specifically set forth in Section 00880 of the Project Manual, this Project is subject to State sales and/or use taxes and Bidder is required to include such taxes in its Bid Proposal.
5. Barton Malow Company has been contracted by the Owner in the capacity of Construction Manager for the Project, and as such has the rights and obligations set forth in its contract with the Owner for those services, and shall act as representative of the Owner to the extent required/allowed under its Owner contract.

6. Bid Proposals will be publicly opened on **February 21, 2006 at 2:00pm** by Ann Arbor Public Schools; evaluated by Barton Malow Company, Owner and the Architect, with recommended awards subsequently made by Ann Arbor Public Schools.

The Owner shall not open, consider, or accept a Bid Proposal that is received after the date and time specified for bid submission in this Advertisement for Bids. A signed and notarized Familial Relationship Disclosure Form must be included with the bid.

9. **A pre-bid conference will be held for all trades on February 14, 2006 at 2:00pm** in the Instructional Conference Room at the Ann Arbor Public Schools Bond Office, located at 2555 South State Street, Ann Arbor, MI 48104. All Bidders are responsible for attendance at the pre-bid conference. Pre-bid conference minutes will be distributed to all who are known by Barton Malow Company to have received contract documents, but the Barton Malow Company, Architect and Owner will not be responsible for providing information to those not attending the pre-bid conference. Information disclosed in the pre-bid conference minutes will be considered part of the Bidding and Contract Documents.
10. Bid Proposals shall be on forms furnished by Barton Malow Company in Section 00400. Bidders will be required to submit with their Bid Proposals a Bid Security by a qualified surety authorized to do business in the state where the Project is located, an OSHA Form 300 for the most recent completed year, their worker's compensation Experience Modification Rate (EMR) factor, and any other information required in the Instructions to Bidders. Bidders are required to comply and submit form 00410, Familial Disclosure Form. Bidders shall not withdraw Bid Proposals for a period of forty-five (45) Days after date for receipt of Bid Proposals.
11. The successful Bidder(s) will be required to enter into an agreement with Ann Arbor Public School District on the Agreement Form identified in Section 00500 of the Project Manual.
12. The right to reject any or all Bid Proposals, either in whole or in part, or to waive any informalities or irregularities therein is reserved by the Owner.
13. All Bid Proposals shall be accompanied by the Familial Relationship Disclosure Form included in Section 00410 of the Project Manual, in accordance with MCL 380.1267, disclosing any familial relationship that exists between the owner(s) or any employee of the Bidder and any member of the school board or the superintendent of the school district. Bid Proposals that do not include this sworn and notarized disclosure statement shall not be accepted.

14. Bid Security in the form of a bid bond issued by a qualified surety, certified check or cashier's check in the amount of five percent (5%) of the Base Bid amount will be required at the time of submission of the Bid Proposal. Bid bonds shall be duly executed by the Bidder, as principal and by a surety that is properly licensed and authorized to do business in the state in which the Work is to be performed.
