The Avondale School District will receive firm prime contractor bids for the Carpet Replacement at Avondale Middle School located at 1445 Auburn Rd, Auburn Hills, MI 48309. The work will consist of removal of existing flooring and installation of new carpet.

The bidding documents consist of plans and specifications as prepared by TMP Associates, Bloomfield Hills, MI. Documents may be obtained with a \$50.00/set refundable deposit payable to the Avondale School District at the office of the Construction Manager, George W. Auch Company, 735 South Paddock Street, Pontiac, MI 48341, 248.334.2000, on or after May 22, 2006.

The envelope bearing your proposal must identify your company and the proposal being bid and addressed to the attention of Mr. Tim Looch, Assistant Superintendent, Business Services Avondale School District, 260 S. Squirrel Road, Auburn Hills, MI 48326. Bids must be delivered no later than **12:00 noon, Wednesday, June 7, 2006** to Avondale School District at the address noted above or the George W. Auch Company. Each proposal must be submitted in writing on the forms included in the specifications. Each proposal shall be sealed in an opaque envelope and marked with the name of the bidder.

Bids will be publicly opened and read at a meeting at the Avondale School District Business Office starting at 2:00 p.m., Wednesday, June 7, 2006.

All contracts to be entered into by the Avondale School District must and will comply with the equal opportunity laws and prevailing wage rates of the State of Michigan.

All bidders must provide familial disclosure in compliance with MCL 380.1267 and attach this information to the bid proposal. The bid proposal will be accompanied by a sworn and notarized statement disclosing any familial relationship that exists between the owner or any employee of the bidder and any member of the Avondale School District Board or the Avondale School District Superintendent. The District will not accept a bid proposal that does not include this sworn and notarized disclosure statement.

Proposals must include a Treasury listed bid bond or certified check made payable to Avondale School District for not less than five percent (5%) of the contract for each proposal over \$18,915 and must be submitted on the bid proposal form furnished with the specifications. All proposals shall remain firm for a period of sixty (60) days.

The Board of Education reserves the right to accept or reject any or all bids, either in whole or in part; to award contract to other than the low bidder; to waive any irregularities and/or informalities; and in general to make awards in any manner deemed to be in the best interests of the owner.

Successful bidders whose proposals are \$50,000 or more will be required to furnish a Satisfactory **U.S. Treasury listed** Performance and Payment Bond in the amount of 100% of their bid. The cost of the Bond shall be included in each proposal.

The Board of Education reserves the right to reject any and/or all bids in whole or in part and to waive any informality therein. The Board of Education reserves the right to accept that bid which in its opinion, is in the best interest of the Owner.
