Footnotes

(1) Applications Received is defined as the number of requests for fingerprint clearances received by the MSP for the purpose of obtaining a license to carry a pistol concealed.

(2) Licensing Board Decision is based on MCL 28.425b(7)(n), which states that issuing a license would be detrimental to the safety of the applicant or to any other individual.

(3) Information on suicides was obtained from the Department of Community Health (DCH) and compared to the concealed pistol database.

(4) Average Cost Per Permit is based on information submitted via a survey of each county. Not all counties submitted this information.

(5) The Mean, Median, Shortest Amount of Time for FBI Clearance, and Longest Amount of Time for FBI Clearance is based on a statistically significant sample of requests.
