

INVITATION TO BID

Cassopolis Public Schools hereby invites bidders to bid on **ROSS BEATTY HIGH SCHOOL ATHLETIC FIELD POWER IMPROVEMENTS**.

Bids will be received at the Cassopolis Public School's Administration Building, Jefferson Red Brick School; 22096 Brick Church Road; P.O. Box 98, Cassopolis, Michigan until **2:30 PM [local time] June 17, 2005** at which time and place bids will be publicly opened and read aloud. Bids received after this time will not be considered and will be returned to the bidder unopened.

The work includes a new 600-amp, 480-volt service panel for the football field & track; new 100-amp service panel for Proposed Stadium Restrooms; new 200-amp service panel for the Baseball Concession Stand; new circuits for various Baseball / Softball / Soccer / Football practice fields. General construction work, employing subcontractors as required to complete the project as designed, and in accordance with the contract Documents.

The Work shall be constructed in full accordance with the Construction Drawings and Specifications prepared by: CARMI Design Group Inc., 68817 Cass Street, Edwardsburg, Michigan 49112.

Bids shall be properly and completely executed on the Bid Proposal Form included within the Project Manual and submitted in duplicate. Bids shall be clearly marked as "**Athletic Field Power Improvements**" on the front of the submitted envelope. A five percent (5%) Bid Bond shall accompany each bid. The successful bidder will be required to provide a Performance Bond, Labor and Material Bonds, and certificates of Liability and Worker's Compensation Insurance. No bidder may withdraw their bid for a period of **Thirty (30) calendar days** after the date set for bid opening.
