1. M04RA000433	04/14/2004	Oakland	Skunk	Skunk noted in back yard for 2 days in same location, homeowner moved to doghouse and wrapped in blanket. Homeowner took to DVM for euthanization, tested positive. 3 HB's exposed, no bites, scratches. None treated. Cats in household-inside only and current on vaccinations. No domestic animals known to have been exposed.
2. M04RA000639	05/20/2004	Lenawee	Bat	Bat on grass in daylight, 6-year-old picked up and was bitten. No domestic animals known to have been exposed.
3. M04RA000705	06/07/2004	Genesee	Bat	Patient showering, felt contact, found bat. No known bite, etc. No domestic animals known to have been exposed.
4. M04RA000793	06/14/2004	Tuscola	Bat	Bat in home, 4-year-old caught bat, handled it. 2 cats not vaccinated. 6 mo. Quarantine being established. To be monitored by Sanilac County Animal Control due to no animal control in Tuscola.
5. M04RA000858	06/21/2004	Muskegon	Bat	Bat picked up in yard (with gloves), submitted to animal control. No pets/livestock at premises of bat collection. No animal or HB exposure at premises, but neighbor has a dog that roams the area. HD recommending booster. Dog is current on license and vaccinations.
6. M04RA000994	07/09/2004	Mecosta	Bat	Bat in home during night. Sleeping couple, bat landed on the nose of the female. Both receiving P.E.P. No animals (pets, livestock) on premises.
7. M04RA001020	07/13/2004	Jackson	Bat	Bat found in home in sleeping area, bedroom doors open. 5 HB's exposed, 2 adults, 3 children. No domestic animals in household.
8. M04RA001027	07/13/2004	Clinton	Bat	Bat in house, family exposed. 2 dogs current on rabies vaccination (spring 2004). 9 horses, some vaccinated but some new additions unsure of vaccination history. Advised to work w/DVM to vaccinate and keep current.
9. M04RA001040	07/14/2004	Washtenaw	Bat	Found dead bat on floor, outside bedroom. Dog loose in house at the time. Dog was vaccinated 3/26/04 (3 year), boosted and 45 day observation.

10.	M04RA001119	07/21/2004	Gladwin	Bat	Bats in house, overnight with open bedroom doors. 5 local HB's on PEP, also 3 relatives visiting from Texas (now returned and receiving PEP at home. No domestic animals in home.
11.	M04RA001110	07/21/2004	Roscommon	Bat	12 year old springer spaniel caught in back yard. Current on rabies vaccination. Boosted and 45 day observation. No HB exposure.
12.	M04RA001117	07/21/2004	Montcalm	Bat	Farm finding dead bats on lawn. 2 dogs had contact with a sick bat. Both current, receiving boosters and 45 day observation. No HB's exposed.
13.	M04RA001152	07/26/2004	Lake	Bat	1 HB exposed (sleeping) now on PEP. 2 adult dogs current on RV. 1 pup (2 months old) with no vaccination history will enter 6 month quarantine.
14.	M04RA001182	07/28/2004	Osceola	Bat	5 dead bats in yard over a few weeks. Submitted last one for testing. Dog current on vaccination. 45 day observation and booster. Horses not vaccinated will be vaccinated 1 st of next week. Advising PEP for 5 home residents (HB's). 1 cat unvaccinated, euthanized/not tested.
