Report on Request for Consolidation of Atherton Community Schools and

**Bentley Community Schools** 

In January the Office of the Superintendent received a communication from Thomas Svitkovich, Superintendent, Genesee Intermediate School District, regarding a request from the Boards of the Atherton Community Schools and the Bentley Community Schools to consider consolidation of the two school districts.

Section 380.852 of the Revised School Code allows for local school boards to initiate proceedings for consolidation. Executive Order 1996-12 transferred the approval authority from the State Board to the Superintendent.

On January 24, 2003, I approved the election plans for Atherton Community Schools and Bentley Community Schools to consolidate into one school district. In order for the consolidation request to become effective, it will require an affirmative vote of the electors in all three school districts.

Dear Mr. Watkins:

I am writing regarding requests we have received from two Genesee County school districts to conduct a consolidation vote. Included you will find copies of resolutions from the Atherton Community Schools and the Bentley Community Schools requesting that we initiate proceedings for the consolidation of their districts consistent with Public Act 451 of 1976, the Revised School Code, Section 380.852. Section 852(1) of the above-mentioned statute indicates that should the intermediate school district receive resolutions requesting the initiation of proceedings for consolidation, the intermediate superintendent shall refer the question to the State Board for its approval. We understand that as a result of an Executive Order, you as the State Superintendent, may approve this request for a consolidation vote. The resolutions specify that a consolidation vote take place on March 31, 2003; therefore, our timeline for approval is very tight.

As you recall, a consolidation vote was held this past month in three Genesee County school districts. The citizens of the Atherton Community Schools, Bendle Public Schools and the Bentley Community Schools voted on December 9, 2002. The results of that vote affirmed consolidation in both Atherton and Bentley. However, the voters of Bendle rejected the issue. Therefore, the boards of both Atherton and Bentley decided to ask their voters to approve a consolidation dropping Bendle from the ballot.

School district consolidation has been a point of discussion in the City of Burton for many years. Many news articles and editorials have been written regarding the process and possibilities for consolidation. Over time, feasibility studies have also been completed weighing the benefits. The two most recent studies, one completed by Mr. William Young, current Atherton interim superintendent, and the November-December 2001 EPIC MRA survey provided positive results related to consolidation.

Based on the information I have reviewed, the results of the most recent election and the long-standing history of this continuing consolidation discussion here in Genesee County, it is my best recommendation that the consolidation question be put before the voters of the Atherton Community Schools and the Bentley Community Schools. I have discussed this recommendation with the members of the Genesee Intermediate School District Board of Education, and they individually concur. I recommend that you authorize the election in order that the districts can begin immediately to move forward with the necessary scheduling details.
