

## INVITATION TO BID

Bids will be received at the three Rivers Community School's Administration Building, 851 Sixth Ave.; Three Rivers, Michigan until **9:00 AM [local time] May 8, 2006** at which time and place bids will be publicly opened and read aloud. Bids received after this time will not be considered and will be returned to the bidder unopened.

**The work includes the replacement of Locker Room Lockers and Toilet Partitions. General construction work, employing subcontractors as required to complete the project as designed, and in accordance with the Contract Documents.**
