How to get the most from Treasury's web site along with easier and more efficient navigation.


### Business Taxes:

From this page you have access to all business tax information and registration for business taxes. You can view pertinent information specific to the tax type selected.

**Business Self Service:** <http://www.michigan.gov/bustax>

The page allows you to view specific account information for Sales, Use, Withholding and Single Business Taxes. This is a secured site and you will need to enter information unique to the account you wish to view. (i.e. Account number, Tax period, Tax amount due)

This site allows you to view specific account information for individual income tax. This is a secured site and you will need to enter information unique to the account you wish to view. (i.e. Social Security number, Tax Year, Adjusted Gross Income)
