Bids are to be submitted in a sealed envelope supplied by the Construction Manager, **McCarthy & Smith Inc.** The bid division being bid is to be identified on the outside of the envelope.

All bids should include 2 copies (1 original, 1 copy) of the Proposal Pricing Form (Section 00300) and the Proposal Execution Form (Section 00400). **The Proposal Execution Form provides a space for the bidder to disclose any familial relationship as required by the State of Michigan and this form must be signed and notarized in order for the bid to be accepted.**

There will be a pre-bid meeting at Tuesday May 23, 2006 at 3:00 p.m. at Woodhaven-Brownstown School District, Board of Educational Office, 24975 Van Horn Road, Brownstown, Michigan 48134.

The purpose of the meeting will be to review the bidding requirements, schedule, project scopes of work, and to answer any question that bidders may have. Bidders are strongly encouraged to attend.

Any and all questions with regards to the bidding or the Project Documents should be addressed in writing to the Construction Manager, **McCarthy & Smith Inc. (fax 248-427-8401) Questions** or clarifications will be promptly answered and returned to the bidder/bidders.

Each bid shall be accompanied by a Bid Security in the amount of five (5) percent of the amount of the bid, payable to the Woodhaven Brownstown School District, as a guarantee that if the proposal is accepted, the bidder will execute the contract and file the required bonds within ten (10) days after notice of award of contract. Bid securities may be in the form of a Bid Bond or Certified Check.

The Board of Education for the Woodhaven-Brownstown School District reserves the right to accept and/or reject all bids, as they judge to be in the best interest of the school district.
