



NOTICE TO BIDDERS

Zeeland Public Schools, Zeeland, Michigan, will receive proposals from qualified contractors for a Pool Video System at Zeeland West High School, Zeeland, MI 49464.

The Owner will enter into a single contract with the successful **Video System Contractor**. The successful Contractor will be fully responsible for coordination of all required work between all trades.

Note: Where “contractor” is referred to in these specifications, this shall be interpreted to refer to the **Video System Contractor**, unless noted otherwise.

Proposals must be mailed or delivered in person to Zeeland Public Schools, 183 West Roosevelt, Zeeland, MI, 49464, Attn: Mr. Gord DeRoo. All proposals must be sealed in envelopes, plainly labeled “Pool Video System – Zeeland West High School” and must be received prior to 1:30 P.M., local time, on Wednesday, July 19, 2006. This will be a public bid opening. Evaluation of proposals and award will be at a later date; the successful contractor will receive a letter of intent prior to receipt of contract.

The Schedule of Work shall be as follows:

July 19, 2006	Bids Due

July 24, 2006	Anticipated start of construction
August 22, 2006	Anticipated substantial completion

All bidders are required to furnish Bid Security in the amount of five (5%) percent of the Base Bid. Form of the security may be a bid bond, certified or cashiers check. This will be a guarantee that the bidder selected by Zeeland Public Schools will furnish the required PLM Bonds; failure to do so could mean forfeiture of the Bid Security.

All bidders must indicate, where shown on the Proposal Form, the cost of Performance and Labor and Material Payment Bonds covering 100% of the value of the Project. Do not include the cost of the Bonds in the Base Bid.

All bids shall be accompanied by a sworn statement disclosing any familial relationship that exists between the owner(s) or any employee of the bidder and any member of the Board of Education of the School District or the Superintendent of the School District. The Board of Education shall not accept a bid that does not include a sworn and notarized familial relationship disclosure statement.

Applicable Michigan use and sales tax apply to this project.

All bidders should note that this project does not require prevailing wages.
