The project includes the construction of the apron expansion including approximately 20,000 square yards of Portland cement concrete aircraft rated pavement and associated bituminous pavement. The project also includes the demolition of existing roads, parking lots and associated infrastructure; terminal area lighting and associated electrical improvements; jet blast fence and perimeter/security fence; storm drainage system; miscellaneous utilities improvements; pavement markings; restoration; and other related site work.
