Separate Sealed Bid Proposals marked **2 Unit Box Hangar and Site Preparation** will be accepted from contractors at the office of the Airport manager, at the Mackinac County Airport, St. Ignace, Michigan until **2:00 p.m.** Local Time, **March 21, 2012**, at which time and place all Bid Proposals will be publicly opened and read aloud. No faxed or unsealed bids will be accepted. All Bid Proposals shall be submitted in sealed envelopes marked as to the bidder and the contents therein. No Pre-Bid Meeting will be held. Prospective bidders may examine the site by first contacting the Airport Manager for approval to access the site. Contractors may bid on one or all three projects, however each project will be evaluated individually and combined bids will not be accepted.

Bid security required is five percent (5%) of base bid amount.

Bidders Note that the proposed procurement is or will be funded as a Federal Aid Project under the provisions of the Airport and Airways Act of 1982 as amended. Certain mandatory Federal requirements are included in the specification. **Uncertainty regarding status of 2012 Federal Airport Improvement Funds may delay or preclude award of this project.** The bidder's attention is directed in particular to the Equal Employment Opportunity and other labor requirements as detailed therein. Davis Bacon Wage Requirements will apply to this project.
