STATE OF MICHIGAN, COUNTY OF LIVINGSTON

The complaining witness says that on the date above and at/or in the multiple counties in Michigan, the defendant, contrary to law,

COUNT 1: TERRORISM

did knowingly, willfully, deliberately and with premeditation commit violent felonies, to wit: fire a handgun at persons driving motor vehicles, that the defendant knew or had reason to know was dangerous to human life while intending to intimidate or coerce a civilian population, or influence or affect the conduct of government or a unit of government through intimidation or coercion;

The following are violent felonies committed by the Defendant in support of the charge of terrorism:

2. On or about October 16, 2012, Defendant did fire a weapon at Paul Gustafson while he was driving a motor vehicle; and/or
3. On or about October 16, 2012, Defendant did fire a weapon at Jennifer Ortwine while she was driving a motor vehicle; and/or
4. On or about October 17, 2012, Defendant did fire a weapon at James Francis while he was driving a motor vehicle; and/or
5. On or about October 18, 2012, Defendant did fire a weapon at Howard Hester while he was driving a motor vehicle; and/or
6. On or about October 18, 2012, Defendant did fire a weapon at Michael Baber while he was driving a motor vehicle; and/or
7. On or about October 18, 2012, Defendant did fire a weapon at Stacey Banks while she was driving a motor vehicle; and/or
8. On or about October 18, 2012, Defendant did fire a weapon at Lori Przybylo while she was driving a motor vehicle; and/or
9. On or about October 18, 2012, Defendant did fire a weapon at Aaron Mason while he was driving a motor vehicle; and/or

FELONY: 5 Years or \$2,500.00; Mandatory forfeiture of weapon or device [See MCL 750.239]

COUNT 5: WEAPONS - FELONY FIREARM

did carry or have in his possession a firearm, to-wit: handgun, at the time he committed or attempted to commit a felony, to-wit: carrying a dangerous weapon with unlawful intent; contrary to MCL 750.227b. [750.227B-A]

FELONY: 2 Years consecutively with and preceding any term of imprisonment imposed for the felony or attempted felony conviction; Mandatory forfeiture of weapon or device [See MCL 750.239]

COUNT 6: WEAPONS - FIREARMS - DISCHARGE FROM VEHICLE

did intentionally discharge a firearm from a motor vehicle in a manner as to endanger the safety of another; contrary to MCL 750.234a. [750.234A]

FELONY: 4 Years and/or \$2,000.00; Mandatory forfeiture of weapon or device [See MCL 750.239]

COUNT 7: WEAPONS - FELONY FIREARM

did carry or have in his possession a firearm, to-wit: handgun, at the time he committed or attempted to commit a felony, to-wit: discharge a firearm from a motor vehicle; contrary to MCL 750.227b. [750.227B-A]

FELONY: 2 Years consecutively with and preceding any term of imprisonment imposed for the felony or attempted felony conviction; Mandatory forfeiture of weapon or device [See MCL 750.239]

Upon conviction of a felony or an attempted felony court shall order law enforcement to collect DNA identification profiling samples.

The complaining witness asks that defendant be apprehended and dealt with according to law.

FELONY: Life or any term of years; reimburse government for expenses incurred from violation (see MCL 750.543x & 769.1f)

COUNT 2: ASSAULT WITH INTENT TO MURDER

did make an assault upon Jennifer Kupiec with intent to commit the crime of murder; contrary to MCL 750.83. [750.83].

FELONY: Life or any number of years; DNA to be taken upon arrest.

COUNT 3: WEAPONS - FELONY FIREARM

did carry or have in his possession a firearm, to-wit: handgun, at the time he committed or attempted to commit a felony, to-wit: Assault with Intent to Murder; contrary to MCL 750.227b. [750.227B-A]

FELONY: 2 Years consecutively with and preceding any term of imprisonment imposed for the felony or attempted felony conviction; Mandatory forfeiture of weapon or device [See MCL 750.239]

COUNT 4: WEAPONS - DANGEROUS WEAPON - CARRYING WITH UNLAWFUL INTENT

did, with intent to use the same unlawfully against the person of another, go armed with a handgun; contrary to MCL 750.226. [750.226]
