pay attorney fees in accordance with a contingent fee agreement previously entered into, which this Court deems to be fair and reasonable in view of the nature of this cause;

IT IS FURTHER ORDERED that there shall be no disclosure of the terms of the settlement agreement except as provided in the Settlement Agreements,

IT FURTHER ORDERED that this action is hereby dismissed with prejudice and without costs to any of the parties and reflects a full and complete resolution of this matter.


