# INTRODUCTION

In November 1996, Michigan voters approved Proposal E, authorizing up to three licensed casinos to be built in Detroit. Proposal E subsequently took effect as law on December 5, 1996, as the *Michigan Gaming Control & Revenue Act* (the "Act"). In July 1997, the voter-initiated law was amended by the Michigan legislature. The Act, as amended, (Public Act 69 of 1997) established the Michigan Gaming Control Board (the "Board" or "MGCB") as a Type I agency within the Michigan Department of Treasury, exclusively responsible for licensing, regulating and overseeing casino gaming in Michigan.

The Board is comprised of five Michigan residents appointed by the Governor, with the advice and consent of the Senate. One member is designated by the Governor as the chairperson. The initial five Board members serve staggered terms: one member is appointed to a two-year term, two are appointed to three-year terms, and two to four-year terms. After the initial five Board members serve their staggered terms, all subsequent Board members will be appointed to four-year terms. No more than three members may belong to the same political party. The Board has powers and duties specified in the Act, and other powers necessary and proper to fully and effectively execute, administer and enforce the provisions of the Act relating to the licensing and regulation of casino gaming in Michigan.

# **ACTIVITIES**

On November 22, 1996, two weeks before the new voter-initiated Act took effect, Governor John Engler issued Executive Order No. 1996-09, establishing the ethical standards and restrictions that he would apply in appointing the five members to the Board, ensuring that each member would have no conflicts of interest and would be held to the highest level of integrity. In addition, the Governor appointed State Racing Commissioner Nelson Westrin as Interim Executive Director of Michigan Gaming, a temporary position created by Executive Order No. 1996-10.

Joined by Attorney General Frank J. Kelley and Director of State Police Col. Michael D. Robinson, the Governor held a news conference on November 22, 1996, to announce the two Executive Orders and Mr. Westrin's appointment. The Governor, Mr. Kelley and Col. Robinson pledged their united commitment to properly implement Proposal E, and ensuring that all necessary laws, regulations and safeguards were put in place to protect the

public's interest and to provide for a fair, honest and legitimate casino gaming environment in Michigan.

Pursuant to the Governor's order, Mr. Westrin immediately began making preparations to enable and assist the State and the yet-to-be-appointed Board in the timely and proper implementation and administration of the new Act. Mr. Westrin continued to serve as both Racing Commissioner and Interim Executive Director of Michigan Gaming until July 17, 1997, when the Governor appointed him to a six-year term as Executive Director of the Michigan Gaming Control Board. This new position was created under the amended Act. Upon appointment to this new position, Mr. Westrin resigned his post as Racing Commissioner.

In December 1996, the Governor appointed the five members of the Michigan Gaming Control Board:

- **Mr. Thomas Denomme, Chairman** (term expires December 2000) Mr. Denomme retired in December 1997 as Vice-Chairman and Chief Administrative Officer of the Chrysler Corporation.
- Ms. Paula Blanchard (term expires December 1999) Ms. Blanchard is the former Michigan First Lady. She has extensive experience in business, public relations and politics.
- Mr. Rich Davis (term expires December 1999) Mr. Davis is a former Director of the Michigan Department of State Police, and is currently Project Director for the Michigan Truck Safety Commission.
- Mr. Taylor Segue III (term expires December 2000) Mr. Segue was an attorney in private practice in Detroit. Mr. Segue resigned from the Board in January 1997. He was replaced in February 1997 by Ms. Karen Batchelor Farmer. Ms. Farmer, also an attorney, is Manager of Civic and Government Affairs at Michigan Consolidated Gas Company.
- **Hon. Michael Stacey** (term expires December 1998) Judge Stacey is a former Wayne County Circuit Court Judge who retired in 1994. He has remained active by assisting with alternative dispute resolution and by serving as a visiting judge.

The Board held its first public meeting in January 1997. From its inception, the Board encouraged public input into the procedures to be followed in licensing and regulating the Detroit casinos. To remain responsive to the views of the people of Michigan, 12 public meetings were held by the Board in 1997 during evening hours to conduct official business and give the public and news media opportunity to voice opinions and ask questions about the Board and its activities.

All Board meetings were held in accordance with the Michigan Open Meetings Act (Public Act 267 of 1976) as required by the Act.

Meetings held early in 1997 included lively discussion and spirited comment from citizens who presented to the Board their views regarding casino gaming. In later months, the public and news media came to realize that the role of the Board was to implement and administer the Act, and that the Board was committed to the expeditious implementation of those provisions.

The first order of business for the Board was to organize itself as a new State agency and to develop a framework for conducting its day-to-day duties and responsibilities under the Act. This was accomplished through a series of Resolutions adopted by the Board during its public meetings.

- **Resolution No. 1997-01** (January 23, 1997) Approving the Board's organizational chart and personnel specifications, and authorizing the Executive Director to hire necessary personnel
- **Resolution No. 1997-02** (January 23, 1997) Approving the employment of Nelson Westrin as Executive Director
- **Resolution No. 1997-03** (January 23, 1997) Authorizing the Executive Director to lease necessary office space; manage and conduct the day-to-day business of the Board; and make necessary expenditures of Board funds

- **Resolution No. 1997-04** (January 23, 1997) Authorizing the Executive Director and the Legislation & Rules Subcommittee to draft Administrative Rules for Board review and approval, and to begin the rulemaking process
- **Resolution No. 1997-05** (January 23, 1997) Directing the Executive Director and Administration & Operations Subcommittee to develop casino license application forms for Board review and approval
- **Resolution No. 1997-06** (January 23, 1997) Directing the Executive Director and Communications Subcommittee to develop a Media Relations Policy for Board review and approval
- **Resolution No. 1997-07** (January 23, 1997) Establishing an Interim Code of Ethics for Board members, employees and agents
- **Resolution No. 1997-08** (January 23, 1997) Directing the Board Chairman and a second Board member to meet with representatives of Mayor Archer's Casino Advisory Committee and the Detroit City Council to discuss proper coordination and discharge of respective duties and responsibilities of the Board and City officials under the Act
- **Resolution No. 1997-09** (January 23, 1997) Requesting and urging the State Legislature to enact necessary legislation to amend and supplement Proposal E
- **Resolution No. 1997-10** (February 25, 1997) Authorizing the Board chairman to send a letter to the leadership of the Michigan Senate and House of Representatives urging their support for passage of new legislation developed and proposed by the Board to amend and strengthen Proposal E
- **Resolution No. 1997-11** (April 15, 1997) Approving the Board's Media Relations Policy
- **Resolution No. 1997-12** (August 28, 1997) Directing the Executive Director to begin the rulemaking process for the Board's proposed Administrative Rules
- **Resolution No. 1997-13** (December 2, 1997) Directing the Executive Director to continue the rulemaking process for a revised draft of the Board's proposed Administrative Rules

# NOTABLE BOARD ACCOMPLISHMENTS

- Established the Board's main office at 1500 Abbott Road in East Lansing
- Established a temporary Board office in Detroit for use by the Board and Michigan Department of State Police Gaming Section
- Hired and trained 19 Board employees
- Developed and recommended necessary legislation to amend and strengthen Proposal E for consideration by the Michigan Legislature
- Urged the Michigan Legislature to enact proposed amendatory legislation to strengthen the Board's licensing and regulatory powers in the Act, and provide for more stringent standards and controls to ensure that casino gaming in Michigan is fair, honest and free of corruption
- Developed and approved a comprehensive set of Administrative Rules for promulgation under the Michigan Administrative Procedures Act (Public Act 306 of 1969)
- Developed necessary application forms for casino, supplier and casino employee licenses

In addition, the Michigan Department of State Police created, staffed and trained a new specialized Gaming Section as part of the Southeast Michigan Criminal Investigation Division. This Section provides the Board with necessary investigative and enforcement assistance in carrying out its duties and responsibilities under the amended Act.

The Michigan Attorney General also established a new Casino Control Division to work inhouse with the Board to provide necessary legal assistance to the Board and its staff to properly discharge their duties and responsibilities under the amended Act.

All operational costs of the State Police Gaming Section and the Attorney General Casino Control Division are reimbursed by the Board pursuant to the amended Act.

# **CHRONOLOGY**

While the Act requires the Board to submit an Annual Report on activities occurring during the previous calendar year, the Board felt it would be informative to offer a perspective by including a chronology of significant activities occurring prior to 1997 related to the legalization of various forms of gaming activity in Michigan.

Both legislative committees conduct public hearings; numerous bills introduced in Legislature to amend or supplement Proposal E

Detroit Casino Advisory Committee issues Report to Mayor Archer

City Council adopts Casino Competitive Development Selection Process Ordinance

City Council adopts Gaming Enterprise District Ordinance (Mayor's Request for Proposals/Qualifications process for selection of Detroit casinos must be consistent with ordinances)

Mayor responds to his Casino Advisory Committee's Report; issues Phase One Request for Proposals/Qualifications for development of three authorized Detroit casinos; rejects Committee's "cluster" recommendation; identifies certain areas in Detroit where casinos may be located; leaves open issue of temporary casinos; announces he wants at least 50% of casino employees to be Detroit residents

July 1997

11 prospective casino developers submit responses to Mayor Archer's Phase One Request for Proposals/Qualifications

Mayor selects and announces seven of 11 respondents as eligible to submit proposals in response to City's Phase Two Request for Proposals/Qualifications to develop three Detroit casinos

Mayor issues Phase Two Request for Proposals/Qualifications; narrows areas where development of casinos could occur; rejects concept of land-based temporary casinos; states that he will consider temporary riverboat casino proposals

September 1997

Legislative Service Bureau reviews proposed Administrative Rules for publication in Michigan Register; **Board receives written public comment regarding proposed Administrative Rules** 

October 1997

Board's proposed Administrative Rules are published in *Michigan Register* along with notice of November 6, 1997, public hearing on Administrative Rules; **Board continues to receive written public comment regarding proposed Administrative Rules** 

Seven prospective Detroit casino developers submit proposals to Mayor Archer in response to his Phase Two Request for Proposals/Qualifications

November 1997

Board conducts public hearing on its proposed Administrative Rules as part of formal rulemaking process under Michigan Administrative Procedures Act

Board secures temporary office space at 1333 Brewery Park Boulevard, Detroit

Mayor Archer narrows list of potential Detroit casino developers to four

Mayor selects and announces final three proposed Detroit casino developers: Atwater/Circus Circus; Greektown/Sault Ste. Marie Tribe of Chippewa Indians; and MGM Grand; Mayor begins Development Agreement negotiations with each selected developer

December 1997

Board approves proposed Administrative Rules (with revisions) for promulgation, and submits proposed Rules to Legislative Service Bureau for certification as to proper form, classification, arrangement, and numbering, in accordance with the rulemaking process under Michigan Administrative Procedures Act

#### MINORS AND COMPULSIVE GAMBLING

The amended Act requires that the Board include in its Annual Report certain information that each casino licensee must compile annually regarding minors and compulsive gambling. Since no casino has yet been licensed by the MGCB, no such information has been compiled.

#### **STAFF**

**Note A: Summary of Revenues** - Since no casino was licensed in 1997, the Board received no revenues from license applicants, licensees, or licensed casino operations under the Act. With the exception of application and license fees, revenues will not be received from the three Detroit casinos until the casinos are licensed and operational. 1997 MGCB expenditures were financed from General Fund advances approved by the Department of Management & Budget. General Fund advances will be reimbursed with interest from the State Casino Gaming Fund in an amount and manner consistent with the operating practices of the State's Common Cash Fund.

# **SUMMARY OF PUBLIC ACT 69 OF 1997**

As previously noted, Proposal E, as approved by Michigan voters in the November 1996 statewide general election, was substantially amended by the Michigan Legislature in July 1997. In summary, the amended Act (Public Act 69 of 1997):

- Gives exclusive authority for licensing, regulation, and control of casino gaming in the state to the Michigan Gaming Control Board
- Provides for the licensing, regulation, and control of casino gaming operations, manufacturers and distributors of gaming equipment and supplies, casino employees, and those who participate in gaming
- Establishes licensing standards and procedures for issuance of casino licenses, casino supplier licenses, and casino employee licenses
- Imposes civil and criminal penalties for violation of the Act
- Imposes and authorizes certain taxes and fees on casinos and others involved in casino gaming
- Provides for the distribution of casino tax revenue for K-12 public education in Michigan, and for capital improvement, youth programs, and tax relief in the City of Detroit
- Creates certain funds for the operation of the Board and compulsive gambling prevention programs
- Establishes certain safeguards to prevent compulsive and underage gambling
- Restricts certain political contributions by casino gaming interests to state and local political candidates and committees
- Establishes a Code of Ethics for members, employees and agents of the Board, license applicants, licensees, and others involved in gaming
