Sheriff plate fees: \$13 for each pair of vehicle plates or a single motorcycle plate. \$5 for plate replacements.

Expiration: Non-expiring, but all plates that are lost or destroyed must be reported to the Michigan Department of State, Internal Services Section.

Municipal Plates – These plates may be applied for at any Secretary of State office, by mail, or by fax. Plates will be mailed from Lansing within 10 days.

Sheriff Plates – These plates cannot be applied for at a Secretary of State office. They must be applied for by mail or by fax. Plates will be mailed from Lansing within 10 days.

Fee: \$10 for each plate. Plates may be transferred to another vehicle in the organization's name for \$10. An additional fee is charged for electric and hybrid vehicles.

Expiration: Plates expire on December 31 in the fifth year following date of issuance.

ELIGIBLE NONPROFIT ORGANIZATIONS: Check **one**. *All vehicles must be titled in the name of the organization.*

- Civil Air Patrol – Any of its vehicles
- A nonprofit recycling center – Any of its vehicles
- Nonprofit Veterans Center – Any of its vehicles
- A nonprofit food pantry or nonprofit food bank – Any of its vehicles
- A nonprofit organization for its vehicles used to transport equipment providing dialysis treatment to children at camp
- A federally-recognized nonprofit conservation organization – Any of its vehicles
- A federally-recognized nonprofit charitable organization for emergency support vehicles used exclusively for emergencies
- Nonprofit Senior Citizens Center – Any of its vehicles except trailers
- A nonprofit veteran's organization for its motor vehicles having a truck chassis and a locomotive or ship's body used exclusively for parades and civic events

Non-public schools and non-profit organizations listed below (check **one**) for use **only** on a **bus, station wagon, or window van** (no trucks, no trailers) if the vehicle is designated by proper signs showing the organization operating the vehicle.
