The revised paragraph language is as follows:

CONTRACT AND CONTRACT AWARD: The Owner intends to award a Contract to the lowest responsible Bidder, provided the Bid has been submitted in accordance with the requirements of the Bidding Documents, and does not exceed the funds available. The lowest Bid will be based on the sum of the Base Bid and any additive or deductive Alternates the Owner accepts as listed in the Bid Summary Form. The Owner will accept an Alternate only if all other previously listed Alternates are also accepted. However, the award will comply with the Public Act 91 of 2005; businesses owned by Qualified Service-Disabled Veterans get a 10% pricing preference. "Service-Connected Disability" is defined as a disability incurred or aggravated in the line of duty in the active military, naval, or air service as described in 38 USC 101(16). "Qualified" means a business entity that is 51% or more owned by one or more veterans with a service-connected disability. The Contractor will be required to submit applicable bonds and insurance. Upon acceptance by the State, this document will constitute the Contract and the executed duplicate will be returned to the Contractor. The Contract, however, is not in force until the Contractor has complied with all of the requirements of insurance and bonds.
