The Board of Education of Algonac Community Schools is accepting firm, sealed bids for all labor, materials, equipment and all other services to complete Asbestos Abatement at Algonac High School, Algonquin Middle School, Algonac Elementary School, Pointe Tremble Elementary School and Fair Haven Elementary School for Algonac Community Schools.

Specifications and proposal forms can be obtained at the mandatory walk through. A **mandatory** pre-bid walk through is scheduled for February 23, 2010 at 3:00 p.m. Meet at Algonac High School 5200 Taft Rd., Algonac, Michigan 48001 – Main Office. Your proposal marked “Asbestos Abatement Bid” will be accepted during regular business hours at the **ADMINISTRATION BUILDING 1216 ST. CLAIR BLVD., ALGONAC, MICHIGAN 48001**, but must be **HAND DELIVERED OR DELIVERED BY COURIER NO LATER THAN 2:00 P.M. MARCH 11, 2010. BID PROPOSALS RECEIVED AFTER THIS TIME WILL NOT BE CONSIDERED OR ACCEPTED. IF MAILING YOUR PROPOSAL VIA THE POST OFFICE, SEND TO THE SAME ADDRESS.** Oral, telephone, fax, or electronic mail bids are invalid and will not receive consideration.

All bids will be publicly opened and read aloud immediately thereafter at the Administration Building located at 1216 St. Clair Blvd., Algonac, Michigan 48001.

No bids may be withdrawn for at least 60 days after the bids are opened. All bids must be submitted on the forms provided in the bid packet.

All bidders must provide familial disclosure in compliance with MCL 380.1267 and attach this information to the bid proposal. The bid proposal will be accompanied by a sworn and notarized statement disclosing any familial relationship that exists between the owner or any employee of the bidder and any member of the Algonac Community Schools Board of Education or the Superintendent of Algonac Community Schools. The District will not accept a bid proposal that does not include this sworn and notarized disclosure statement.

Proposals must include a bid bond or certified check made payable to Algonac Community Schools for not less than 5% of the contract and must be submitted on the bid proposal form furnished with the specifications. All proposals will remain firm for a period of 60 days and provide performance/labor and material bonds upon award.

The Board of Education reserves the right to accept or reject any or all bids, either in whole or in part, to award contract to other than the low bidder; to waive any irregularities and/or informalities; and in general to make awards in any manner deemed to be in the best interests of the owner.
