The bid proposal shall be accompanied by a sworn and notarized statement disclosing and familial relationship that exists between the owner or any employee of the bidder and any member of the Battle Creek Public Schools Board or the Battle Creek Public Schools Superintendent. The District will not accept a bid proposal that does not include this sworn and notarized disclosure statement
