PROPOSALS: Sealed proposals for the aforementioned project shall be received at the Business Office of Battle Creek Public Schools, Willard Library Building – 2nd Floor East, 3 VanBuren St., Battle Creek, MI 49017, **until 1:00 p.m., Thursday, August 27, 2009.** Bids will be publicly opened and read aloud. Proposals received after specified time will not be accepted and will be returned unopened. **All bids must be placed in an opaque envelope with "Attn: Denny Welling, Exterior Gym Painting at Springfield Middle School" clearly marked on the outside of the envelope."**

TYPE OF CONTRACT: One Lump Sum Bid is being solicited. Owner intends to award Purchase Order. All contractors shall comply with the Michigan Prevailing Wage Act.

PRE-BID CONFERENCE: No pre-bid conference is scheduled. Bidders are encouraged to visit the building site at their convenience. All work areas can be seen from building exterior.

DOCUMENT LOCATIONS: Interested bidders may obtain a hard copy set of Contract Documents upon nonrefundable deposit of \$10.00 per set, plus payment of shipping and handling charges, by calling the office of the architect. No deposit or fee will be requested for documents e-mailed in .pdf format from the architect's office. Bidding Documents will also be available for examination at the following locations: McGraw Hill Dodge, Grand Rapids, MI; Builders and Traders Exchange in Lansing, Grand Rapids, and Kalamazoo, MI; Construction News Service, Wyoming, MI.

PROPOSAL GUARANTEE: Bid Bond or Certified Check of not less than 5% of the bid amount shall be submitted with Bid and made payable to Battle Creek Public Schools.

CONTRACT SECURITY: Bidder, if awarded a contract, shall furnish Performance Bond and Labor and Materials Bond, each in the full amount of the Bid Proposal, and insurance as specified.

FAMILIAL RELATIONSHIP DISCLOSURE: As required by the State of Michigan, P.A. 232 of 2004, all bids must be accompanied by a sworn and notarized statement disclosing any familial relationship that exists between the owner or any employee of the bidder, and any member of the school board, or the superintendent of the school district. The owner will not accept a bid that does not include this sworn and notarized disclosure statement.
