

## INVITATION TO BID

Carson City-Crystal Area Schools hereby invites bidders to bid on the **MIDDLE/HIGH SCHOOL 2008 BOND WORK** project, Phase I: Flooring, Ceiling & Restroom Improvements.

Bids will be received at the Carson City-Crystal Area School's Administrative Offices at 115 East Main Street, Carson City, Michigan 48811 until **10:00 AM [local time] July 1, 2008** at which time and place bids will be publicly opened and read aloud. Bids received after this time will not be considered and will be returned to the bidder unopened, unless shipping receipt is dated June 30, 2008 or earlier.

**Work includes VCT flooring, porcelain tile flooring, painting, suspended ceiling tile/grid replacement, plumbing replacement, and lighting replacement.**

The Work shall be constructed in full accordance with the Construction Drawings and Specifications prepared by: CARMI Design Group Inc., 68817 Cass Street, PO Box 627, Edwardsburg, Michigan 49112.

Bids shall be properly and completely executed on the Bid Proposal Form included within the Project Manual and submitted in duplicate. Bids shall be clearly marked as "**MIDDLE/HIGH SCHOOL 2008 BOND WORK**" on the front of the submitted envelope. A five percent (5%) Bid Bond shall accompany each bid. The successful bidder will be required to provide a Performance Bond, Labor and Material Bonds, and certificates of Liability and Worker's Compensation Insurance. No bidder may withdraw their bid for a period of **Thirty (30) calendar days** after the date set for bid opening.
