Bids shall be prepared in accordance with specifications outlined in Request for Bid.

Bids will be publicly opened on **Wednesday, May 13, 2009 at 2:00 p.m.** local time, by Chippewa Valley Schools, 19120 Cass Avenue, Clinton Twp, MI 48038, evaluated, with awards subsequently to be made by Chippewa Valley Schools.

A pre-bid conference **will not** be held, although bidders are allowed to visit the site. Site visits must be scheduled at the least disruptive time for the school building. **All visitors must check in at the main office upon arrival to any school.**

Bids shall be on forms furnished by Chippewa Valley Schools. Bid security by a quality surety in the form of a bid bond, cashier check, or certified check in the amount of five percent (5%) of the total bid cost shall be submitted with the bid.

A bidder will be permitted to withdraw his bid, unopened, after it has been submitted if so requested prior to the time specified above for opening of bids. The successful bidder shall be required to enter into a contract with Chippewa Valley Schools.

Owner is exempt from all taxes. A tax exemption certificate will be issued upon request.

All bidders must provide familial disclosure in compliance with MCL 380.1267 and attach this information to the bid proposal. The bid proposal will be accompanied by a sworn and notarized statement disclosing any familial relationship that exists between the bidder or any employee of the bidder, and any member of the Board of Education of the school district, or the Superintendent of the school district. The District will not consider a bid proposal that does not include this sworn and notarized disclosure statement.

The right to reject any or all bids, either in whole or in part, or to waive any informalities or irregularities therein, is reserved by Chippewa Valley Schools. The Board of Education will not consider or accept a bid received by the Board after the date and time specified for bid
