

1.1 NOTICE TO BIDDERS

- A. Comstock Public Schools, Kalamazoo, Michigan, will receive proposals from qualified contractors for Electrical Improvements at three buildings:
1. East Elementary School, 175 Hunt Street, Kalamazoo, MI 49048
 2. Green Meadow Elementary School, 6171 East MN Avenue, Kalamazoo, MI 49048
 3. North Elementary School, 3100 North 26th Street, Kalamazoo, MI 49048
- B. The Electrical Contractor shall be the Prime Contractor for the project. The Owner will enter into contract with the successful Electrical Contractor who will be fully responsible for all work, and for the coordination of all required work between all trades.
- C. Proposals must be mailed or delivered in person to Mr. Todd Mora, Comstock Public Schools, 3010 Gull Road, Kalamazoo, MI 49048. All proposals must be sealed in envelopes, plainly labeled "Elementary Electrical Improvements" and must be received prior to **2:00 P.M.**, local time, on **Thursday, June 3, 2010**. This will be a public bid opening. Bids will be opened at the Administration Office. Contractors will be notified within the allocated period of time as to their position in the bid process. Evaluation of proposals and award will be at a later date; the successful contractor will receive a letter of intent prior to receipt of contract.
- D. A pre-bid meeting will be held at 1:30 P.M., local time on **Tuesday, May 25, 2010** at the Gull Road facility located as noted above.

- F. All bidders are required to furnish Bid Security in the amount of five (5%) percent of the Base Bid. Form of the security may be a bid bond, certified or cashiers check made payable to Comstock Public Schools. This will be a guarantee that the bidder selected by Comstock Public Schools will furnish the required PLM Bonds; failure to do so could mean forfeiture of the Bid Security.
- G. All bidders must indicate, where shown on the Proposal Form, the cost of Performance and Labor and Material Payment Bonds covering 100% of the value of the Project. Do not include the cost of the Bonds in the Base Bid.

- H. All bids shall be accompanied by a sworn statement disclosing any familial relationship that exists between the owner(s) or any employee of the bidder and any member of the Board of Education of the School District or the Superintendent of the School District. The Board of Education shall not accept a bid that does not include a sworn and notarized familial relationship disclosure statement.
- I. Applicable Michigan use and sales tax apply to this project.
- J. All bidders should note that this project does not require prevailing wages.
