



What is the Energy Purchasing Cooperative Program?

Several years ago, the State of Michigan began working collectively with interested public organizations to leverage cooperative purchasing power. Today, the resulting State of Michigan Energy Purchasing Cooperative is still driven by members, with quarterly meetings held to discuss program goals and gather feedback.

By taking advantage of the Energy Purchasing Cooperative's competitively bid contracts, you can spend more time and resources overseeing high-level data instead of researching and analyzing daily market conditions.

The Energy Purchasing Cooperative includes purchases not only for natural gas, but electricity, energy conservation, and performance contracting.

Benefits of the Energy Purchasing Cooperative Program

Benefits include: management of the natural gas program, access to the State's industry consultant, discount group pricing, budget planning process, and financial reporting tools.

The State of Michigan pays the monthly bill from the energy supplier, and invoices individual members for their allocated portion based on utility nominations. This enables the energy supplier to offer more aggressive pricing.

The Cooperative is investigating sourcing strategies that can provide further price improvements and security in supply, including; additional storage capacity contracts with the utilities, and royalties in kind on Michigan gas wells.

How to Join?

Who can join?

Some size restrictions apply, for economic reasons. Members must have an annual consumption on one meter of at least 20,000 MMBTU. The Cooperative can accommodate members with existing contracts, and encourages at least partial participation. Members may purchase all or just part of their natural gas requirements through the Cooperative.

The State of Michigan Energy Purchasing Cooperative is open to the following entities*: cities, villages, counties, townships, school districts, intermediate school districts, non-profit hospitals, institutions of higher learning, and community or junior colleges.

How much time should be allowed to switch my service to the Cooperative?

Please plan on at least thirty days for a smooth transition between suppliers.

When can I join the Cooperative?

You may join at any time.

How big is the Cooperative?

The Cooperative currently buys 5 BCF annually, and its members include State agencies, public universities, K-12 schools, counties, and cities.

Is there a fee?

Members pay a \$100 monthly fee, invoiced with their natural gas bill.

What is the Cooperative's purchasing strategy?

Each member has a custom-made plan for their natural gas program, and determines their own individual purchasing strategy and level of management involvement. The plan can be changed, one month in advance, for the next month.
