ADVERTISEMENT FOR BIDS

Notice is hereby given that Harrison Community Schools will be accepting Bids for the Replacement of portions of the roof at Hillside Elementary School, according to drawings and specifications as prepared by Wakely Associates, Architects and Engineers.

Sealed Bid Proposals will be received from the "Roofing Contractors" only. All other subcontractors shall submit to the "Roofing Contractor".

I. PROPOSAL REQUIREMENTS

The Harrison Community Schools will receive sealed proposals until 2:00 P.M., eastern daylight time, on Tuesday, August 13, 2008. Proposal shall include one of the bid forms indicating the Base Bid amount in a sealed envelope marked, "Roofing Proposal". Proposals should be forwarded in a sealed envelope to Mr. Kelly Hileman, Business Manager, 224 South Main Street, Harrison, MI 48625-0524. All bid proposals will be publicly opened and read aloud.

Sealed bid proposals must be on the forms furnished by the Architect/Engineer and be accompanied by a bid bond from an authorized surety company or certified check in the amount of 5% of the bid proposal submitted.

The accepted bidder will be required to furnish satisfactory performance bond and labor and material bond, each in 100% of the contract.

II. CONTRACT DOCUMENTS:

Contract Documents (Plans and Specification) may be obtained at the office of the Architect/Engineer: Wakely Associates, 916 Washington Avenue, Suite 210 Davidson Building, Bay City, MI 48708, and will be on file on and after July 29, 2008 and may be examined at the following locations:

A check in the amount of \$50.00 must be submitted by Roofing Contractors as a deposit for a set of plans and specifications, same to be refunded to bidders submitting proposals upon return of plans and specifications in good condition within ten (10) days of the opening of bids. Maximum per contractor - Proposal "R" (2) sets on a deposit basis.

Plans may be obtained by subcontractors and suppliers at the cost of reproduction and handling (\$50.00). Roofing Contractors may obtain sets beyond the maximum on deposit basis at cost of reproduction and handling (\$50.00).

There will be a \$20.00 mailing/shipping fee for those contractors requesting documents to be sent to them. This shall be a separate check made payable to Wakely Associates.

III. PRE-BID CONFERENCE

A Pre-Bid Conference will be conducted at 3:45 P.M., eastern daylight time, on August 5, 2008, at the site. Questions and discussions will be

entertained regarding the bidding process, construction documents and any other matters that are of interest. A tour of the roof will follow.

Substantial completion date for this project shall be as indicated under the Supplemental Conditions, Article 8.1.5.

The Harrison Community Schools Board of Education reserves the right to accept and/or reject any or all bid proposals and to waive any and all informalities and/or irregularities in bid proposals submitted. This right shall be exercised at the sole discretion of the Board of Education. The Board of Education will make award as may appear to be in the best interest of the School District.
