No oral, telephonic, telegraphic or facsimile proposals will be considered. No proposals will be considered after the time of closing of bids. **There will not be a public bid opening.**

The Board of Education reserves the right to accept or reject any or all items in the bid; to accept or reject any or all bids; to waive any informalities therein; or for reasons of establishing uniformity, to award the contract to other than the low bidders. If either a unit price or extended price is obviously in error and the other is obviously correct, the incorrect price will be disregarded.

Prices bid are to be F.O.B. Hesperia, Michigan. All purchases are to be exempt from all taxes, including state and federal taxes. Exemption certificates will be furnished upon request.

All bids shall be firm for sixty (60) days from the date of the bid opening. For bids to be considered they must meet or exceed all specifications herein.

All bids shall be accompanied by a signed statement disclosing any familial relationship that exists between the owner or any employee of the bidder and any member of the Board or Superintendent of the District.
