All contractors **are required** to attend. Bids will **not** be accepted from contractors who do not attend the mandatory bidders' meeting.

A walkthrough of the site will immediately follow the mandatory bidders' meeting. **Hard hats are required.**

Each bid shall be accompanied by a certified check, cashier's check, money order or bid bond made payable to Lakeview Public Schools in an amount not less than five percent (5%) of the base bid as a Bid guarantee.

The successful contractor shall provide a Labor and Material Payment Bond and a Performance Bond, each in the amount of one hundred percent (100%) of the contract amount.

Withdrawal of any bid is prohibited for a period of one-hundred twenty (120) days after the actual date of the opening thereof.

The Owner reserves the right to reject any or all bids, either in whole or in part, to reject a bid not accompanied by the required bid guarantee, or by other data required by the RFB documents and Michigan law or to reject a bid which is in any way non compliant with the bid requirements. Submitted bids may be adjusted by unit prices included by the contractor to ensure all bids submitted are compared on the same basis with respect to required materials.

The Owner reserves the right to accept alternates in any order or combination and to determine the low contractor on the basis of the sum of the base bid and the alternates accepted.
