PROPOSAL GUARANTEE: A bid bond executed by a U.S. Treasury Listed Surety Company in favor of the Owner or a cashier's check in the amount of at least five percent (5%) of the base bid payable to Lapeer Community Schools shall be submitted with each proposal. This bid bond shall accompany each proposal. Successful bidder will be required to furnish and pay for satisfactory Performance and Payment Bonds.

**FAMILIAL RELATIONSHIP
DISCLOSURE:**

All bidders must provide familial disclosure in compliance with MCL 380.1267 (P.A. 232 of 2004) and attach this information to the bid. The bids shall be accompanied by a sworn and notarized statement disclosing any familial relationship that exists between the owner and any employee of the bidder and any member of the board of education or the superintendent of Lapeer Community Schools. The Owner will not accept a bid that does not include this sworn and notarized disclosure statement.

PREVAILING WAGES:

The Successful Bidder shall ensure that the requirements of the Michigan Prevailing Wage Act, Public Act No. 166 of 1965, as amended, are complied with in regard to all work performed. A schedule of rates for wages and fringe benefits as determined by the Michigan Department of Labor and Economic Growth for all classes of construction mechanics to be used on the work is attached and made part of the specifications.
