Sealed proposals for the work identified in the contract documents must be received before **2:00 p.m. on June 15th, 2009** and publicly opened at that time at the Mt. Clemens Community School District, Central Services Building, 161 Cass Avenue, Mt. Clemens, MI 48043.

Clemens Community School District shall accompany the bids. Mt. Clemens Community School District will not accept a bid that does not include this sworn and notarized disclosure statement.
