A Lump Sum bid will be considered for:

The Board of Education will receive bids until 2 pm on January 7, 2010 at New Haven Board of Education Office, 58233 Gratiot Ave, New Haven, Michigan. Bids received after this time will not be accepted. Bids will be opened and publicly read aloud at 2:15 pm at New Haven High School, New Haven, Michigan. All interested parties are invited to attend.

Bidding Documents may be examined at the office of the Architect.

Successful bidders shall conform with the "Schedule of Common Construction Wages" included with the Supplementary Conditions.

A bid security in the form of AIA Document A310, a certified check or a form from an acceptable surety shall accompany each bid. The bid security shall be in the penal amount of 5 percent of the total bid. Bid security shall be forfeited if bid is withdrawn after closing time on date for receiving bids.

All bids shall be accompanied by a sworn statement disclosing any familial relationship that exists between the owner(s) or any employee of the bidder and any member of the Board of Education of the School District or the Superintendent of the School District. The Board of Education shall not accept a bid that does not include a sworn and notarized familial relationship disclosure statement.

Successful bidders are required to furnish a satisfactory Performance and Payment Bond from an acceptable surety in an amount equal to 100 percent of the full contract sum.

Bidders may obtain copies of the documents from the Architect by depositing \$50.00 for each complete set of documents. No partial sets will be issued by deposit. Deposits are to be payable the New Haven Community Schools, (the Owner) and shall be sent or delivered to the architect. Deposits are fully refundable to each "Document Holder" if documents are returned to the Architect in good condition within 10 days after the bid closing date.

Each bidder shall be limited to no more than 3 complete sets of Contract Documents under the refundable deposit provisions. Bidders may request additional, complete sets of documents beyond the initial 3 sets for the nonrefundable cost of \$50.00per set.

A prebid conference will be held on December 9, 2009, at 2 p.m. , local time, in the office of the architect, Fanning Howey, Associates. Attendance by bidders is optional, but recommended, in order to clarify or answer questions concerning the Drawings and Project Manual for the Project.

No bidder may withdraw their bid within 60 days after the actual date of the bid opening thereof.
