All bidders will be required to provide bid security in the amount of five percent (5%) of the bid. Bid security shall be in the form of a bid bond or certified check.

A deposit of \$100.00 is required for each set of Bidding Documents. A partial set of documents will not be issued. A shipping and handling fee of \$25.00 per set of Bidding Documents is required for mailing of Bidding Documents to Contractors. Separate checks are to be made payable to Muskegon Construction Company.

A Mandatory Pre-Bid Meeting will be held on December 15, 2010, 2:00 PM at the Educational Services Agency. Bidders are advised to become completely familiar with site conditions.

All bids shall be accompanied by a sworn statement disclosing any familial relationship that exists between the owner(s) or any employee of the bidder and any member of the Board of Education of the School District or the Superintendent of the School District. The Board of Education shall not accept a bid that does not include a sworn and notarized familial relationship disclosure statement.

It is the goal of NCRESA to utilize, in the activities described herein, residents within the county of Newaygo as available and as much as is economically feasible, while retaining the high quality of construction required of this project. NCRESA will consider, in evaluating which bids best serve the interest of the Owner, the extent to which bidders are able to achieve this goal.
