**Pittsford Area Schools** will receive sealed bid proposals for construction trade work from qualified general contractors for the **2010 Window Replacement Project**. **The total project will include approximately 85 windows (Owner furnished) and exterior finish insulation system (EFIS). Performance bonds shall be required of the successful bidder. This is not a prevailing wage job.**

A **MANDATORY** pre-bid meeting will be conducted by Mende, Burke and Associates, LLC on **Tuesday January 26, 2010, at 4 pm local time at the Pittsford Area Schools, 9304 Hamilton St, Pittsford, MI 49271**. Bidders are asked to report to the Community Education room of the High School.

Proposals may be mailed or delivered in person to Mr. Andrew Shaw, Superintendent, Pittsford Area Schools, 9304 Hamilton St., Pittsford, Michigan 49271. **Proposals must be received prior to 4 pm on Wednesday, February 10, 2010**, at which time Proposals will be opened publicly and read aloud at the Pittsford Area Schools Community Ed Room of the High School. All bids will be evaluated after the bid opening. All bids received **after** the bid receipt deadline will be returned unopened. Facsimile or electronic submission of bids will not be accepted.

A Bid Security in the amount of five percent (5%) of Base Bids shall accompany each proposal or proposal combination. The Bid Security may be in the form of a Bid Bond, Cashier's Check, or Money Order. Bids may not be withdrawn for a period of thirty (30) days after the bid date
