ADVERTISEMENT FOR BIDS

Notice is hereby given that Shiawassee-Regional Education Service District (RES D) will be accepting General Contract Bids for remodeling of the existing Corunna Office Building, 1024 North Shiawassee Street, Corunna, MI 48817.

General Contract shall include the following:

I. PROPOSAL BEING RECEIVED:

Proposal for the above work will be received as one contract:

Proposal "G" General Contract

Sealed Bid Proposals will be received from "General Contractors" only. All other subcontractors shall submit to the "General Contractor"

II. PROPOSAL REQUIREMENTS

Shiawassee RESD will receive sealed proposals until **2:00 PM, eastern daylight time on February 27, 2008**. Proposals should be forwarded in a sealed envelope to Mr. John E. Hagel, Superintendent, Shiawassee RESD, 1025 North Shiawassee Street, Corunna, MI 48817.

Sealed bid proposals must be accompanied by a bid bond from an authorized surety company or certified check in the amount of 5% of the bid proposal submitted. The accepted bidder will be required to furnish satisfactory performance bond and labor and material bond, each in 100% of the contract. Prevailing Wage Rates of pay will be required for this project.
