St. Joseph Public Schools is seeking offers under seal for two projects: Roofing Work at E.P. Clarke, Lincoln and St. Joseph High Schools. Interior corridor lighting work at E.P. Clarke . Address sealed bids to Mr. John Ruddell, Business Manager. All bids will be received until 2:00 P.M. (Michigan Local Time), March 27, 2009, at St. Joseph Public School Offices located at 3275 Lincoln Avenue, St. Joseph, Michigan. The offers will be opened and read publicly in the adjacent Board Room starting at 2:00 P.M. (local time) on March 27, 2009. Late bids cannot be accepted. All bidders shall bid in accordance with and upon the Bid Form included in the Contract Documents. Submit two copies of Bid Proposal.

Project Description: Work consists of complete roof tear-off to E.P. Clarke Elementary, Lincoln Elementary, and St. Joseph High School roofs. New insulation and a single-ply thermal plastic membrane and metal perimeter flashings installed at all schools. Interior work at E.P. Clarke will include lighting replacement in all corridors.

Bids will be on a stipulated sum basis.
