Advertisement for Bids

Tecumseh Public Schools will receive sealed bid proposals for work from qualified **Concrete Contractors** for the **Tecumseh Public Schools Concession and Restroom Building Foundation**. **Scope of work shall include foundation work**. Foundation work shall include all labor, materials, excavation and permits. A **mandatory** pre-bid meeting is scheduled for **Friday, June 19, at 10:00 a.m., local time, at the athletic fields under construction at the High School (located at 760 Brown St., Tecumseh, MI)**.

All proposals shall be mailed or delivered in person to Mr. Mike Gilpin, Facilities Manager, 700 S. Maumee St., Tecumseh, Michigan 49286. Proposals must be received **prior to 10 a.m. on Tuesday, June 30, 2009**, at which time Proposals will be opened publicly and read aloud at the Tecumseh Public Schools Maintenance Office, 700 S. Maumee St., Tecumseh, Michigan. All bids will be evaluated after the bid opening. All bids received **after** the bid receipt deadline will be returned unopened.

All bids shall be submitted on the bid forms provided in the project specifications and completed in accordance with the project specifications. Facsimile bids **will not** be accepted.

The Owner's forms, rather than industry master forms, are used for all documents. The bidders shall read and review the Bidding Documents carefully, and familiarize themselves thoroughly with all requirements.

Requests by **Contractors** for inclusion as Bidders shall be addressed to Todd Dailey, Dailey Engineering, phone: 517/467-9000. **Bidding documents will be available for review and/or refundable purchase of \$15 a set and \$10 nonrefundable mailing charge on Tuesday, June 16, 2009** at Dailey Engineering, 8485 Stephenson Rd, Onsted, Michigan 49265. All questions regarding the bidding procedures, design, and drawing/specification intent are to be directed to Todd Dailey, Dailey Engineering, phone: 517/467-9000.

A Bid Security in the amount of five percent (5%) of Base Bids shall accompany each proposal or proposal combination. The Bid Security may be in the form of a Bid Bond, Cashier's Check, or Money Order. Bids may not be withdrawn for a period of thirty (30) days after the bid date. Successful bidders may be required to furnish Surety Bonds as stated in the project specifications.

All bidders shall provide familial disclosure in compliance with MCL 380.1267. The bid shall be accompanied by a sworn and notarized statement disclosing any familial relationship that exists between the Owner or any employee of the bidder and any member of the Board of Education of the Tecumseh Public Schools, or the superintendent of the Tecumseh Public Schools. By law, the Tecumseh Public Schools shall not accept a bid that does not include this sworn and notarized disclosure statement. A form will be enclosed in the specification's booklet under section 00305 that shall be used for this purpose.

The Project Completion Date is July 7, 2009.

The Owner reserves the right to reject any or all proposals, accept a bid other than the low Bid, and to waive informalities, irregularities and/or errors in the bid proposals which they feel to be in their own best interest.
