All quotes will be evaluated at a later date. No late, faxed or e-mailed quotes will be accepted.

Project Description: Provide general furniture for the Thornapple Kellogg High School, including student desks and chairs, teacher desks and chairs, computer tables, conference tables and chairs, science tables, office furniture, filing and cabinets, task chairs, and other similar items as indicated.

As required by State Law (P.A. 232 of 2004), all quotes shall be accompanied by a sworn and notarized statement disclosing any familial relationship that exists between any employee of the vendor and Thornapple Kellogg Schools or any member of the school board or the superintendent of the school district. Quotations that do not include this sworn and notarized disclosure statement will not be accepted.

Vendors will be required to provide bid bond in the form of a surety bond, certified check, or cashier's check in the amount of 5 percent of the quote amount.

Quotation documents may be obtained from the office of the architect as of Monday, February 9, 2009 after 1:00 p.m. with a refundable deposit in the amount of \$50.00 for one set. Each vendor may receive up to three sets. Additional sets may be purchased for \$50.00 per set, non-refundable.

The deposit will be forfeited by vendors that do not return the quotation documents in good condition within ten working days after the bid opening date.
