The Walled Lake Consolidated School Board of Education will receive firm prime contractor bids for the installation of a Fire Alarm Upgrade at: Walled Lake Western High School located at 600 Beck Road, Walled Lake, MI 48390.

The **bidding documents** consist of plans and specification prepared by Peter Basso Associates, Inc., Troy, MI. Documents may be obtained with a \$100 per set refundable deposit payable to Walled Lake Consolidated Schools at the office of the Construction Manager, George W. Auch Company, 735 S. Paddock St., Pontiac, Michigan 48341, Ph 248.334-2000, or after 1:00p.m., Wednesday, March 17, 2010.

A pre-bid meeting and walk-through will be held at 2:30 p.m. on Tuesday, March 23rd. Attendees are to meet at the main lobby of Western High school located 600 Beck Road, Walled Lake MI 48390 prior to the start of the meeting.

Bids shall be delivered **no later than 1:00 p.m. E.S.T. Thursday, April 1, 2010**. The Board of Education will not open, consider or accept a bid received after the date and time specified for bid submission. All late Bid Proposals will be returned to the bidder unopened.

Each proposal must be submitted in duplicate, on the forms furnished by the engineer and must be completed in full. The proposal shall be sealed in an opaque envelope and marked with the name of the bidder and the project name, addressed to:

Bids will be publicly opened and read at the Educational Services Center, located at 850 Ladd Road, Building D, Walled Lake, Michigan 48390 starting at 1:00 p.m. Thursday, April 1, 2010.

Bid shall be accompanied by a **sworn notarized statement disclosing any familial relationship** that exists between the owner or any employee of the bidder and any member of the Board of Education or Superintendent. The Board of Education shall not accept a Bid Proposal that does not include this sworn and notarized statement.

A **bid bond** executed by a Treasury listed surety company acceptable to the Walled Lake Consolidated School District, or a cashier's check in the amount of at least 5% of the sum of the proposal payable to the Walled Lake Consolidated School District shall be submitted with each proposal over \$20,998. All proposals shall be firm for a period of sixty (60) days.

Successful bidders whose proposals are \$50,000 or more will be required to furnish a satisfactory **Performance and Payment Bond** by a treasury listed surety in the amount of 100% of their bid. **The cost of the Bond shall be included in each proposal.**

The Board of Education reserves the right to reject any and/or all bids in whole or in part and to waive any informalities therein. Walled Lake Schools reserves the right to accept that bid which in its opinion, is in the best interest of the Owner.
