This meeting and walk through will be mandatory for any contractor proposing on the HVAC scope of work.

The envelope bearing your proposal must identify your company, the proposal being bid and is to be addressed to the attention of Mr. William Chatfield, Director of Operations, Walled Lake Consolidated School District, 46740 W. Pontiac Trail, Walled Lake, Michigan 48390. **Bids must be delivered not later than 12:00 noon, E.S.T., Tuesday April 22, 2008** to Walled Lake Schools at 46740 W. Each proposal must be submitted on the forms furnished by the architect and must be completed in full. Each proposal shall be sealed in an opaque envelope and marked with the name of the bidder. A bid bond executed by a Treasury listed surety company acceptable to the Walled Lake Consolidated School District, or a cashier's check in the amount of at least 5% of the sum of the proposal payable to the Walled Lake Consolidated School District shall be submitted with each proposal over \$20,102. All proposals shall be firm for a period of ninety (90) days.

Bids will be publicly opened and read at the Educational Services Center, Room 900, located at 850 Ladd Road, Building D, Walled Lake, Michigan 48390 starting at 2:00 pm, April 22, 2008.

Successful bidders whose proposals are \$50,000 or more will be required to furnish a satisfactory Performance and Payment Bond by a Treasury listed surety in the amount of 100% of their bid. The cost of the Bond shall be included in each proposal.
