Wayland Union Schools is soliciting sealed bids for ASBESTOS ABATEMENT at PINE and STEEBY ELEMENTARY for Wayland Union School District. Sealed bids will be received at the Wayland Union Schools Administration Office, 500 100<sup>th</sup> Street SW, Ste. 5, Byron Center, MI 49315, **prior to 3:00 p.m., Thursday, February 26, 2009**; at which time bids will be publicly opened and read aloud at 3:30 pm. Bids will **not** be accepted after 3:00 p.m.

Bid Documents are available for viewing after February 10, 2009 at Wayland Union Schools Central Receiving located at 324 West Sycamore, Wayland, Michigan 49348 between the hours of 10:00 am and 4:00 pm.

A mandatory Pre-bid Walk thru will be held at Steeby Elementary Cafeteria at 435 E. Superior St., Wayland Michigan 49348 on February 20, 2009 at 4:00 pm. Site examinations will be conducted by the Project Administrator during the Pre-Bid Meeting at the owner and administrators discretion.

All bids shall be accompanied by a sworn statement disclosing any familial relationship that exists between the owner(s) or any employee of the bidder and any member of the WUS Board of Education or the Superintendent of Wayland Union Schools. The WUS Board of Education shall not accept a bid that does not include a sworn and notarized familial relationship disclosure statement. Bids must be marked on the envelope, "ASBESTOS ABATEMENT" and the bidder's name must be identified on the envelope. Bids should be addressed to **Jim English, Assistant Superintendent of Finance & Operations, Wayland Union Schools**. Bid Security will be required, and Performance and Labor and Material Bonds are required for all projects equaling to and exceeding \$50,000.00. Wayland Union Schools' Board of Education reserves the right to accept or reject all or any portion of a bid, and is not bound to accept the low bid. A bid may be rejected, if not accompanied by a required bid security or by other data required by the Bidding Documents, or which is in any way incomplete or irregular. Wayland Union Schools shall have the right to waive informalities or irregularities in a bid received, and to accept a bid which, in the judgment of Wayland Union Schools, is in the best interests of Wayland Union Schools.
