Bid Requirements

No bidder may withdraw bid within 90 days after opening thereof. Bidders shall furnish a 5% Bid Bond (or Certified Check), made payable to: Jonesville Community Schools. Bond shall accompany sealed proposal.

Success bidder will be required to furnish 100% Labor and Material Bond and 100% Performance Bond. Include cost in base bid, but provide break out cost of bond.

Prevailing wages are required for this project.

Right to Reject Bids

As required by State Law (P.A. 232 of 2004), all proposals/bids must be accompanied by a sworn and notarized statement disclosing any familial relationship that exists between the Owner or any employee of the bidder and any member of the Jonesville Community Schools' Board or the Superintendent of the School District. The Board will not accept a bid that does not include this sworn and notarized statement.

The Owner reserves the right to waive any informalities or to reject any and all bids, or to award any Contract to other than the low bidder, should it be deemed in their best interest to do so.
