**INFORMATION**

This is the Official Shipping Tag of the Michigan Department of Natural Resources. It is to be used whenever products possessed under a Permit to Hold Wildlife in Captivity or Game Bird Hunting Preserve License are shipped or transported from the licensed premises.

Failure to use this shipping tag as required by Act 451, PA 1994 or any violation of the provisions of this Act is a violation of state law and may result in permit or license revocation, fine and/or imprisonment.

Any animals or parts of animals leaving a licensed premises must be identified with a separate official shipping tag regardless of means of transportation. However, items contained in a package, carton, box, or other container, or items being shipped in a single vehicle to a single destination, may be accompanied by a single shipping tag. The intent is to identify what is being shipped to each destination by individual tag.

The shipping tags must be securely attached to the product or containers, must be readily visible, and must remain attached until the products are ready to be used or consumed or until live animals are released from crates or other containers. A person must not reuse a tag.

The recipient must keep this shipping tag as documentation of legal acquisition. The licensee must keep the original (white) copy of this set for at least five years. Unless otherwise provided, information from this tag must be included on the Monthly Inventory Report of Wildlife in Captivity (PR 1350-2), to be completed and submitted in accordance with the instructions on that form.
