



The 2017 Employee Engagement Survey is almost here and the department wants to hear from all of its employees. This is the first survey taken under Director Washington. She has expressed interest in hearing what is most important to staff and their ideas on how to make the department work even better.

In previous years, participation in this anonymous survey has grown from 48 percent of MDOC employees taking it in 2012 to 71 percent who took it in 2015. The more employees who take it, the better idea the department has of the issues facing our nearly 14,000 employees who are spread across more than 30 facilities and offices and 105 field offices. The answers employees provide truly are important and make a difference. As a result of the last survey, employees identified three key areas for improvement – increased communication; inclusion in the department's decision making process and acknowledgement for a job well done with emphasis on future career growth.

Each of those areas had action plans developed to address and improve upon these concerns.

#### **Communication**

This newsletter has been revamped to help improve

communication about what is taking place in the department. We can use Nixle to share important information, and we started a weekly podcast called "Field Days," where important topics going on in the MDOC are discussed. We also constantly share information on our social media sites like Facebook and Twitter.

For those in FOA, you may have noticed members of the management team dropping in on staff meetings, or spending a day in your office to field concerns and to listen to staff on the front lines.


The communications office added two positions, including a social media coordinator as well. There is also an EPIC subteam focused on communication and MCO and other bargaining units are now included in staff meetings. Suggestion boxes have been created and department and region score cards, vacancy reports, and workload reports are shared regularly.

All of these things are a direct result of previous survey responses.

#### **Inclusion**

The EPIC and efficiency teams across the department were formed also as a result of past surveys. These teams and workgroups were developed to work on

a variety of topics. Local offices even formed their own teams to work on department issues. All measures were implemented to allow staff to become involved with the department's decision making process and to increase their level of involvement and inclusion. So many of the initiatives and new ideas the department has embarked on in recent years have sprung up from employees, including the new Probation Sentencing Specialist Pilot program.

#### **Acknowledgement**

Coins, service awards, shout-outs and certificates are just a few of the things that employees are noticing becoming more common across the department and this too is an outgrowth of previous surveys. It's another way to tell employees they have done a great job, provide them with something tangible as a result and ensure their contributions are acknowledged and recognized.

As a result of past surveys, the department increased the number and visibility of employee awards and certificates. They publicly recognize staff accomplishments in the local offices and facilities. Staff members also use social media to

broadcast the awarding of these certificates to the rest of the staff and to the public.

A greater emphasis on career development through leadership programming, job shadowing and mentoring has also taken place in recent years. Staff have shadowed at the Parole Board, Field Offices, Internet Crimes Against Children and with Embedded Agents. Leaders have initiated regular opportunities for open discussions with employees on career growth. Activities such as "Lunch and Learn" offer opportunities for employees to learn new skills and lunchtime guest speakers have offered staff opportunities to learn about career paths and career growth.

There were other changes that came from the survey as well. CFA incorporated healthier choices in vending machines and expanded the list of "Items Allowed without a Gate Manifest" to include things like fruit.

And staff members across the department have received better tools to perform their jobs, including laptops, iPhones, ergonomic chairs, second computer monitors, updated office furniture, bulletproof vests and multiple security enhancements. Outside of the workplace, staff members have organized social events like a regional bowling tournament and holiday parties. And there has been an increase in participation in community service endeavors and through volunteering, fundraisers, and donations -- the "Kids Food Basket," vegetables from the garden to shelters, and knitted hooded sweaters which were donated to shelters and hospitals for children in need.

The department encourages everyone to please take the time to fill out the survey. It is anonymous, and the results are studied carefully and changes are made as a result.

Survey results are confidential and are never associated with any one particular individual.

## Why do I have to enter my demographic information?

Demographics help direct us to areas where great things are happening and to areas that need attention.

#### What is the Rule of 10?

If there are fewer than 10 responses in any classification, the responses will only be reported from this unit at the next organizational level. If a business unit has 10 or more responses, a report will be generated for this business unit. However, this report will not contain any demographic information.

## Why are my specific comments important?

The comments section is your chance to identify specific issues important to you, both positive and negative. All comments are forwarded to leadership for review.

# Parole and probation supervisor shows support for Special Olympics

Changing lives one step at a time is something that David Katz has been doing since 1995. Katz, a parole and probation supervisor at the Detroit Metro District Parole Office, is heavily involved with the Special Olympics. Katz has been a

"I am proud of the MDOC's involvement with the Special Olympics," Katz said.

"The MDOC is one of the strongest programs in the nation that is involved with the Special Olympics. MDOC volunteers are really willing to give back, and that makes a huge difference in the athletes' lives."

In addition to Katz, other members of the MDOC

have participated in the Law Enforcement Torch Run, which is an organization that helps contribute money to the Special Olympics.

The Law Enforcement Torch Run is a nonstop relay which travels more than 750 miles from

> Copper Harbor to Belle Isle. As of 2011, Katz had been involved with the Law Enforcement Torch Run for 16 years.

Due to his involvement, he was selected to represent the State of Michigan as a final leg runner for the Special Olympics World Summer

Games.

"As a final leg runner I was able to spend three weeks in Greece and carry a torch across the country into Athens," he said.

Katz said his involvement allows him to experience many special moments in the athletes' lives. "Seeing the smiles and enthusiasm from the athletes not only brightens my day, but it brightens my year," he said.

Brooks Correctional Facility and lastly the Richard A. Handlon Correctional Facility.


At MTU she has served as deputy warden since 2014, and

## Remembering former MDOC **Director Gus Harrison**

ormer MDOC Director Gus Harrison, who led this department from 1953 to 1972, passed away on New Year's Day.



During Harrison's nearly 20-year tenure as director, he served under four different governors and made education one of his priorities.

The prison education program through Jackson Community College was expanded, a program that still exists today with Jackson College. Though back then, prisoners left the facility on a bus and traveled to the JCC campus after all the students had left at night, where they would attend classes until 2 a.m. and then be bussed back. Such classes now all take place inside the prisons. Back then, this took place at several other facilities as well during his tenure, one going back to 1957. Then, about 45 prisoners were transported late at night from Camp Pugsley to Traverse City High School for instruction in auto mechanics, drafting and machine shop. These programs are all now taught at the

Vocational Village at the Richard A. Handlon Correctional Facility, opened during Harrison's time as director.

Harrison, who was ahead of his time, had laid out a 10-point plan before he left as director in 1972. Some of those items included the building of a women's prison; creating a unified system of probation; and eliminating employment barriers for exprisoners.

Also before he left the MDOC, plans began to separate the State Prison of Southern Michigan complex into several smaller and more manageable sized prisons. And maybe most memorably to staff, corrections officers received a new wardrobe during his time as director. In 1972, the department began to switch from forest green uniforms, consisting of Eisenhower jackets, matching pants and military caps, to olive sports coats. The idea behind the move was that officers were being trained as behavioral science para-professionals and it was felt at the time that they should dress accordingly and not with the military-type dress of the previous uniforms.

Harrison left the MDOC to become the first director of the State Lottery in 1972, a post he held until 1979.

In 1991, the Gus Harrison Correctional Facility opened in his

"He was a great man and a great leader of this department for many years," MDOC Director Heidi Washington said. "He will be missed by many and our thoughts are with his family."

#### Susan M. Hunter scholarship applications available now

Chidren of Michigan Department of Corrections employees can begin applying for the Association of State Correctional Administrators' Susan M. Hunter Scholarship. Students must be a child of a corrections employee and must have a minimum high school GPA of 3.3.

Undergraduate students can be working in any field of study, while graduate students must be enrolled in a criminal justice program. Students must be enrolled full-time in an accredited two-year or four-year college or university. Scholarship awards are \$1,000 for undergraduate students, \$1,500 for graduate students and \$500 for individuals who recieved a scholarship award through the ASCA in prior years. # WHAT'S NEW IN 2017

A look ahead to what the coming year will hold for the department.

#### **New Vocational Village**

A second Vocational Village will open at the Parnall Correctional Facility in February, with new skilled trades being offered at the site. The Women's Huron Valley Correctional Facility is also slated to open a village there as well.



#### **Pell Grants**

Nearly 1,500 prisoners will take part in college classes this year after the state was awarded Pell Grants by the U.S. Department of Education. Several facilities will house the prisoners taking part, in a setting much like the Vocational Village.



#### **Vivitrol Pilot**

The MDOC recently started offering VIVITROL to offenders being released from RSAT/ASAT and those that violated their parole involving the use of alcohol or opioids. Vivitrol is a once-monthly non-narcotic medication for the treatment of alcohol dependence as well as for the prevention of relapse to opioid dependence. The hope is to better address the nationwide epidemic of opioid abuse which routinely brings people to prison or drives their criminal behavior. Vivitrol like any other medication for opioid addiction, must be accompanied with substance abuse treatment and a strong support system.



#### **Probation Sentencing Specialist Pilot**

A pilot program launched last year will rollout statewide this year, where four specialists will review all straddle cell recommendations. The aim of the program is to create consistency across the state as many counties have varied prison commitment rates, as well as to find programming available regionally or to see the need to create new programming options.



#### **Segregation reform**

Michigan is already a national leader in this area, but we plan to push farther ahead in 2017. The incentives in segregation program at Alger Correctional Facility is a national model and we plan to expand it to all facilities that have additional segregation beds.

## MDOC staff go beyond the call of duty to help others

Diane Suppes, of the Bellamy Creek Correctional Facility recieved the Meritorious Service Award for her positive involvement with an important case. Suppes was the initial breakthrough for the case as she discovered the disturbing letters between an inmate and a mother of a handicapped teenage girl. The letters entailed the making of plans for the inmate to sexually molest the girl with the mother's consent. Suppes notified her supervisors immediately and a joint case between multiple departments was opened against the inmate and the mother. After several months of the case proceeding with Suppes giving a helping hand wherever she could to help out, the inmate was convicted in a new crime along with the mother. Suppes' Meritorious award reflects the great job she did for her department and for her community.





At the Gus Harrison Correctional Facility on January 24, 2016, Mark Eichenberg displayed a great sense of professionalism and awareness in a high stress situation as he responded to a call for assistance from a fellow coworker regarding a prisoner who was attempting to take his own life. The immediate actions of Officer Eichenberg and his coworker to free the prisoner, lowering him to the floor, and providing aid until the health services staff arrived prevented this situation from progressing any worse. Grateful for his conduct, Gus Harrison Correctional Facility, Warden Paul Klee presented Officer Eichenberg the Lifesaving Award.

On May 4, 2015, Ionia Correctional Facility Officer Jeff Luther displayed a great amount of dedication and professionalism when he was the first responder to a horrible head on collision involving an employee from another correctional facility in Ionia and another person. Jeff wasted no time assessing the situation and ultimately ending up holding the mangled car from continuing to roll, long enough for the correctional employee to crawl from the vehicle to safety. From there Officer Luther stayed with the fellow officer until Emergency Services arrived. This unselfish act earned Jeff the Citizenship award.





While working at the Ionia Correctional Facility on Feb 1, 2016, Correctional Officer Patrick Sanborn discovered an unresponsive inmate leaning against the interior wall. Immediately Sanborn called for assistance while beginning Cardio Pulmonary Resuscitation with help from another coworker in hopes of bringing the inmate back. Soon, additional staff arrived with an AED which was used to bring the inmate back and into stable condition. Officer Sanborn's initial contact was instrumental toward saving the inmate's life and for that he earned the Lifesaving Award.

## MDOC staff go beyond the call of duty to help others

On July 31, 2015 Officer Daniel Shaffer was in the transition of moving an inmate from Duane Waters Health Center to Allegiance Health Center, however as soon as the inmate was loaded into the ambulance his heart abruptly stopped beating. Without hesitating, Officer Shaffer began performing Cardio Pulmonary Resuscitation on the inmate for the duration of the trip until arriving at Allegiance where health care staff were waiting to take over. The immediate and proper response by Officer Shaffer greatly assisted the inmate who avoided a major life threatening situation. Officer Shaffer, who works at the Charles Egeler Reception and Guidance Center, was awarded the department's Lifesaving Award.





Maxwell McVean, a Housing Unit Officer at the Charles E. Egeler Reception and Guidance Center, earned the department's Valor Award for his actions displayed on March 22, 2016. McVean, who was alerted by the sound of a fire door alarm activating, saw a prisoner dashing through the door and heading toward the perimeter fence. Immediately McVean called for assistance over the radio as he started chasing the fleeing inmate. It came to a stop as McVean chased the prisoner into an isolated area of the prison where there weren't any exits. From there Officer McVean calmly directed the prisoner to the ground and ordered him to stay in the position with McVean monitoring him until assistance arrived. It was a great representation of controlling the situation before it escalated any further.

On the night of January 11, 2016, Ryan Dean, a Corrections Officer at Woodland Center Correctional Facility, was driving up his driveway as he noticed a Michigan State Police officer searching a nearby empty van. Upon exiting his vehicle, Dean proceeded to check in with the officer to see if everything was ok, and learned the officer was looking for the suspect who fled from the van during a traffic stop. Dean graciously offered his assistance in tracking the suspect, and in short time was able to find the suspect hiding in a trailer. Dean remained on site ensuring the suspect went no further until the MSP officer arrived and arrested the person. Dean was given the Michigan Department of Corrections Citizenship award, for going above and beyond.



## Handicapped parking spaces at MDOC facilities

Employees at several facilities have asked about issues related to handicap and disabled/veteran parking places. This is a friendly reminder that these blue line parking spots are only available to those who have a legitimate handicap plate or a blue handicap placard which is to be displayed from your rear view mirror. Before parking in a blue lined spot, please remember that the following are against state law and can be punishable from a \$500 fine all the way to 30 days in jail.

- Loaning your Disability Placard to another person
- Knowingly using a Disability Placard that has been canceled or
- Knowingly using a Disability Placard or plate when the disability no longer exists
- Using the Disability Placard or license plate of a deceased family member.
- Copying, altering or forging a Disability Placard or License Plate. For those veterans who have the proper handicap plate, but not the needed placard as well, you have the option to obtain a red handicapped sticker from your local Secretary of State building as well. These will take the place of a blue handicap placard and will be placed upon your blue handicap plate, making the blue lined parking spots accessible to you. These spots let the disabled/veteran individual park closer to their destination as well as offer easier foot travel to local sidewalks or buildings ensuring the safety and comfortability for them. Please keep these individuals in mind

that rely on the accessibility of those blue lined parking places and make the correct parking choice.
