Who We Are and What We Do

Educating Our Community

• **Parenting Classes** - Free for families with children aged birth to 5.

29 weekly classes, served 58 parents and 89 children

• **Stewards of Children** - Child sexual abuse prevention training for adults.

7 workshops, educated 113 adults

• **Period of PURPLE Crying** - For parents and caregivers of infants to prevent shaken baby syndrome.

1 presentation educated 50 adults

• **Truancy Prevention** - Classes and assessments for parents and students, a collaboration with the Jackson Family Court.

58 children and 41 adults served

• **Prison Outreach** - Service Fairs and Prisoner ReEntry Program orientations.

Reached over 600 prisoners

• **Informational Fairs and Community**

Events - Distribute child safety and parent education materials to the Jackson Community.

9 events reached 665 participants, 2,324 educational materials distributed

• **Annual Professional Trainings** -

For social workers, teachers and other professionals. 2012's, "Recognizing Child Abuse in Fragile Populations: Children with Disabilities" trained 35 professionals

• **Mandated reporter trainings** -

Offered in conjunction with the Department of Human Services – recognizing and reporting suspected maltreatment to Child Protective Services.
