Coby has partnered with AERCCR, Inc. and its Take-Back and Regulatory Compliance management system to offer this program. Consumers can access the webpage at cobytakeback.aerCCR.com and enter information about their location and the equipment they intend to recycle. Based on this information, a free shipping label is generated and sent to the consumer, which the consumer can utilize to ship their used Coby product for free recycling. Consumers merely pack the product and ship it using the free shipping label.
