E-World Online offers consumers a free mailback program for CED's. Consumers can go to the E-World Online website, click on the "mailback" tab for details. If they require assistance, a full staff is available to answer questions and guide them through the process.

Consumers follow a simple process including typing in their zip code and providing equipment details. A pre-paid shipping label for mailback will be provided. The box will be sent to the consumer. The consumer will pack the box and bring the package to any site that accepts UPS packages for delivery. If it is not practical for a consumer to mail back the equipment, it will be picked up at no charge

Our company works with E-World Online to provide electronics recycling in Michigan. E-World Online provides consumers with information on how and where to return covered electronic devices on its website: www.e-worldonline.com. The site has a map of the United States and consumers can find information on the E-World Online program in Michigan by clicking on the state of Michigan on the map. The E-World Online website lists all brands participating in the mailback program in Michigan.

The E-World Online take back program provides collection locations for consumers who wish to recycle CED's. All brands of CED's are accepted at no charge to consumers at all recycling collection locations.

In addition to the information on the E-World Online MiTS program provided on the Michigan page on the E-World Online website as described in Question 10 above, a consumer can access the Michigan DNRE Electronics Takeback Program via the E-World Online website. 

Covered electronic items received from Michigan consumers are processed by a qualified and certified recycler, whether mailed back or dropped off at a collector or recycler directly. The recyclers utilized by the E-World Online MITS program are R2 or eSteward certified and must provide details of their processing system and all source documentation. E-World Online recyclers process all CED's domestically without the use of prison labor.
