9. Please describe your takeback program.

Xerox has a mature and robust takeback program. The equipment is picked up at a customer location by a network of carriers and returned to a Xerox facility or contracted facility to be torn down and remanufactured. All scrap electronics are sent to recycling facilities. Xerox has contracted with Staples in Michigan to provide the consumer with a place to drop off covered electronic devices. Staples has contracted with a recycler to process those products.

10. What information do you provide to consumers on how and where to return covered electronic devices that are labeled with your name or brand label?

As directed on Xerox's web site, consumers with desktop printers intended for personal use or small businesses with less than ten employees are asked to return electronic waste less than 100 pounds such as desktop printers to their nearest Staples Office Superstore. Consumers with desktop printers intended for personal use or small businesses with less than ten employees in the state of Michigan are asked to return electronic waste greater than 100 pounds by contacting Electronic Recyclers International, Inc (ERI) at 800-607-3292.

11. How do you provide information to consumers on how and where to return covered electronic devices?

Consumers can find the process for returning covered electronic devices carrying the Xerox name on the web site referenced in Question 8a.


13. The processes and methods used to recycle or reuse the covered electronic devices received from consumers:
