

List of DEQ Registered Composting Facilities

The owners or operators of the listed composting operations have submitted a registration form and registration fee as required under Section 11521(4) of Part 115, Solid Waste Management, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended. In addition to submitting the form and fee to the Department of Environmental Quality (DEQ), the composting operation must also comply with Part 115 in order to qualify as a registered composting facility. The information in this list is derived solely from the registration form. The inclusion or exclusion of a composting operation from this list does not reflect a determination by the DEQ on the compliance status of the composting operation under Part 115 or any other state or federal law, rule, or regulation. The DEQ does not recommend or endorse any composting operation and is providing this list to assist municipalities and other generators with identifying potential options for managing any yard clippings they may generate. It is the responsibility of the generator to ensure yard clippings are delivered to a qualified registered composting facility or other facility that manages yard clippings according to PA 212.
