PART 55, AIR POLLUTION CONTROL, NATURAL RESOURCES AND ENVIRONMENTAL PROTECTION ACT, 1994 PA 451, AS AMENDED. The Air Quality Division will be holding a comment period and public hearing on January 26, 2015, at 1:30 p.m. on proposed revisions to administrative rules promulgated pursuant to Part 55, of the Natural Resources and Environmental Protection Act, 1994 PA 451 (NREPA). The rules are identified as Part 9, Emission Limitations and Prohibitions – Miscellaneous. The comment period and hearing will address requirements relative to the state administrative rules and revisions to Michigan’s State Implementation Plan under the federal Clean Air Act. The purpose of these rules revisions is to adopt by reference specific federal regulations and industry testing methods, update some adoption by reference language, and move all adoptions by reference in the AQD rules to R 336.1902 to make the rules easier to use. REQUEST FOR AMBIENT WATER QUALITY DATA FOR MICHIGAN SURFACE WATERS. The Water Resources Division (WRD) is requesting ambient water quality data (chemical, biological, or physical) that has been obtained by other governmental agencies, nongovernmental organizations, or the public for Michigan surface waters from January 1, 2013, through December 31, 2014. All water quality data submitted to the WRD by March 1, 2015, will be evaluated and potentially used to help prepare Michigan’s 2016 Integrated Report. The WRD prepares and submits a biennial report to the United States Environmental Protection Agency to satisfy the listing requirements of Section 303(d) and the reporting requirements of Sections 305(b) and 314 of the Clean Water Act. The Integrated Report describes the status of water quality in Michigan and includes a list of water

bodies that are not attaining Michigan Water Quality Standards and require the establishment of pollutant Total Maximum Daily Loads.
