**PART 55, AIR POLLUTION CONTROL, NATURAL RESOURCES AND ENVIRONMENTAL PROTECTION ACT, 1994 PA 451, AS AMENDED.** The Air Quality Division will be holding a public hearing on May 3, 2012 at 1:00 p.m. on proposed revisions to the Air Pollution Control Rules (ORR 2010-035 EQ). The proposed revisions to Part 2, Air Use Approval, R 336.1201 to R 336.1299, will provide the Department with the legal authority to write and issue permits for facilities that become subject to federal Title V requirements by virtue of their greenhouse gas emissions and will incorporate emissions thresholds for the pollutant PM 2.5. Recently the Michigan Department of Environmental Quality (DEQ) embarked on a Collaborative Stakeholder Initiative (CSI) to reinvent the state’s cleanup and redevelopment programs. The DEQ selected the following seven areas on which to focus recommendations for improvement.

- Brownfield Redevelopment
- Groundwater Surface Water Interface
- Cleanup Criteria
- Part 201 Rules
- Due Care Obligations
- Vapor Intrusion
